2022-2023: Taxes

• We had an extension for filing last year and due to an e-file and routing number mistake our taxes were not pulled correctly on time. They have now been paid.

• We received a notice from the IRS that we owe \$562.19 in penalty and late fees. These have been turned over to our current CPA (Bowers) to resolve and handle.

• Our CPA was out of the office and I should have an update after 7/15 - I will try to send this along with Penny to announce during the meeting if I have one.

<u>2023-2024</u>: end of year update, these are the final numbers for our 2023-2024 year. In summary we ended on 5/31/2024 with:

- \$8,028.51 in AmeriCu
- \$8,320.98 in KeyBank
- These finances are ready to go to an Accountant for tax prep for our filing date of October 16, 2024.

2024-2025: Online banking is live for KeyBank, currently working on AmeriCu access

For finances this year, I propose we move all accounting, bookkeeping, tax prep, and auditing to Kelsey Blackwell with Blackwell Bookkeeping. The reasoning is:

1. Our current CPA has not been responsive in filing correctly or following up with us. They currently cost us \$1,750+ to only file our taxes.

a. This \$1,750+ is a 50% discount from their typical pricing that we were initially quoted in 2015

2. Per AR 210-22 we are required to do an audit at least every other year, or whenever we have a new treasurer. Per the Private Organization Handbook for Fort Drum we need to do an audit every other year. Auditors need to be either a CPA, PA (this is Blackwell Bookkeeping) or 3 club members who don't hold office.

a. Audit services were quoted between \$6,000-\$10,000 per audit from other agencies

3. Blackwell Bookkeeping would provide all the following services for a total of \$3,247 annually:

a. Annual Tax prep and filing for state and federal taxes

b. Paying quarterly sales tax for OTBP

c. Quarterly review of NCSC finances for the both the Club and OTBP

d. Annual year end audit to provide MWR, Garrison and any other agency that requires it. As well as when we have a treasurer hand over (if it should happen mid year)

My recommendation:

1. This is a total cost increase of \$1,497 to support our bookkeeping from last year to this year.

2. For \$1,497 we would gain an annual audit, quarterly review of all finances, and assistance with sales tax prep.

3. These services, and this pricing, I believe are worth it after having worked with Kelsey on the audit this spring. She understands our mission, vision and wants to see us succeed.
