looked at two different buildings that are located close to the NCO Academy. After viewing both buildings, we found out that only one was an option. So, our options were to stay where we are at the airfield, take the building near the NCO Academy, building 4849, or wait several years and move into the MWR Headquarters that would be shared with the Boy Scouts and Girl Scouts. After viewing the buildings and discussing the pros and cons of the options, the Executive Board determined that we would move forward through the process to move into the Building 4849 in which we will sign a 5 year lease to use the building. Colleen with Real Properties said it will take several months before we will be able to move into the building, so we are looking at probably February/March timeframe.
