The Consigner inventory has been completed and updated in the computer system but we are currently still working on the shop inventory.

The shop has had a deep clean and been reorganized

We are looking to do another order for the knitted blankets and based on previous orders the estimated price would be \$736. We are still waiting on an official price quote as of this past week.

We are going to be placing a new order for the 14oz mugs as well! (10th Mountain mugs, NY outline with heart mugs, Drum, and Chair mugs)

Thinking about getting a new printer for the shop and board member use but still looking at options and prices for that.

During the re-opening, it was observed that there were some issues going on with the card reader. There have been a lot of issues with the Paypal Zettle system recently so we are trying to look into possibly switching over to Square. We are currently looking into the price differences between the two since we already have a square account for the website. It would then all be on one system minus Traxia.

I would like to request a vote for the blanket order, the mug order and the new printer as the total cost for all three would be over \$1000.

 Shop will pay up front, the club will pay back half the cost

I just wanted to also say that Sarah has done an absolutely amazing job getting the shop all set up with new inventory, doing a complete inventory check and a beautiful reopening! Big thanks again to Molly as well for helping out so much in the shop!
